Our study found a significant association between lymphopenia, thrombocytopenia and elevated levels of C reactive protein (CRP), procalcitonin (PCT), lactate dehydrogenase (LDH), D-dimer and COVID-19 severity. The results have the potential to be used as an early biomarker to improve the management of COVID-19 patients, by identification of high-risk patients and appropriate allocation of healthcare resources in the pandemic
