The Commonwealth Fund: The Impact of the COVID-19 Pandemic on Outpatient Visits: Changing Patterns of Care in the Newest COVID-19 Hot Spots

The COVID-19 pandemic has brought dramatic changes to the delivery of outpatient care. To decrease the risk of transmitting the novel coronavirus to patients or health care workers, health care practices have deferred elective visits, modified their practices to safely accommodate in-person visits, and increased their use of telemedicine.

In late April, the Commonwealth Fund published findings demonstrating that, early in the pandemic, the number of visits to ambulatory care practices had declined by nearly 60 percent. An update was issued in mid-May showing a substantial rebound in office visits and an update in late June showing the beginning of a plateau in this rebound. In this, the fourth report, they describe visit trends through August 1
